

Started in 1976 at RajajiPuram, Lucknow, the capital of Uttar Pradesh by the dynamic and visionary couple Mr. M.D. Saxena and Mrs. HeeruSaxena it was the first school of RajajiPuram . Facing innumerable odds and lack of basic infrastructure in the newly built colony in Lucknow, this enterprising duo started the school with only 24 students

and within a couple of years, with extreme dedication of teachers and superlative management, the strength swelled to 2500 plus. The students not only brought laurels in the academic sphere but also excelled in sports at district, state and national level. They charted enviable success stories in their chosen fields and careers as well.



# ACADEMIC SESSION, DISCIPLINE & ATTENDANCE

The Academic session begins in April and ends in March of the following year. There are two long vacations, in summers, from third week of May to last week of June and in winters, from last week of December to first week of January.

The school will be closed on all holidays as per the Government Gazette. Attendance is compulsory for all students on Independence Day and Republic Day. Students must report back on the stipulated day after holidays else their names may be struck off the rolls.

According to CBSE rules, 75% attendance is compulsory for all students to be eligible to appear for final/board examinations.

Students with less than 75% attendance will not be allowed to appear for the final examinations in school. Parents are expected to take immediate corrective action for students with irregular attendance.

The school firmly believes in the adage that by constant self discipline and self-control you can develop greatness of character. Students found guilty of misconduct shall be summarily suspended. The decision of the Principal / Manager shall be final in this regard.

# **RULES FOR ADMISSION**

The ordinary time for admission is January against existing vacancies on the basis of interview. However, registration is open from December. Application for admission must be filled in by parent or guardian. Submission of application within stipulated time is responsibility of guardian.

**General Conditions:** i. A student seeking admission to any class in 'School' will be eligible for admission to that class only if he/she has been studying in a school recognized by or affiliated to this Board of Secondary Education in India. ii. has passed qualifying examination making him eligible for admission to that class. iii. Satisfies the requirements of age limits (minimum and maximum) as determined by the State/ U.T Government and applicable to the place where the school is located ; and iv. Produces:- a. School Leaving Certificate/Transfer Certificate signed by the Head of the Institution last attended and countersigned both local and outstation students(NOT MANDATORY FOR CBSE STUDENTS). b. document(s) in support of his having passed the qualifying or equivalent qualifying examination in original.

All the required documents must be submitted within a month from the date of admission. **The admission will be cancelled if the documents will not be submitted on time. The School will not be responsible for the cancellation of the admission due to delay in submission of document.** No REFUND OF FEE PERMITTED.

If the child has attended school for even a single day, fee of six months will be charged, if the child is opting for Transfer Certificate. Parents are requested to confirm the Date of Birth with relevant documents before filling it up in the admission form. In case of discrepancy, the date of birth on transfer certificate/ school documents shall be treated as final.



# RULES & RESPONSIBILITIES OF STUDENTS

The school rules have been established in consonance with CBSE directives and management's vision of discipline and value inculcation. They reflect the school's expectations in terms of acceptable standards of behaviour, dress and personal presentation in the widest sense. Students are expected to follow the school rules at all times when on the school campus or when clearly associated with the school i.e. when wearing school uniform.

## **Students have the responsibility:**

1. To attend school regularly
2. To respect the right of others to learn
3. To respect their peers and teachers regardless of ethnicity, religion or gender
4. To respect the property and equipment of the school and others
5. To carry out reasonable instructions to the best of their ability
6. To conduct themselves in a courteous and appropriate manner in school and in public.
7. To keep the school environment and the local community free from litter
8. To observe the uniform code of the school
9. To read all school notices and bring them to their parents' /guardians' attention
10. **The following are strictly forbidden on school campus : Cellular phones/ Tabs/ CD players/IPods /MP3 Players/ Camera. A fine of Rs. 1000/- will be charged from the defaulter for CARRYING / USING them.**
11. Students MUST NOT indulge in BULLYING. Any form, verbal or physical, or any means of bullying or victimisation is strictly forbidden and will invite immediate suspension/ expulsion.
12. Students MUST NOT wear jewellery or make up. Hair must be of natural colour and not dyed/ highlighted. Excesses of current fashion in relation to style, colour and length are not acceptable.
13. **The length of the hair is to be above the collar, above the eyebrows and off the face. A fine of Rs. 200/- will be charged from students reporting in indecent, fancy, informal haircuts. Such students will NOT BE ALLOWED to attend any class. The school will not be responsible for loss in terms of classroom studies/ test/exam etc.**
14. Boys are to be clean-shaven at all times while representing the school.



15. No motorcycles with gear are allowed for students. No entry of any two wheeler in campus without helmet and required documents.
- A. **GENERAL CONDUCT:** Students are representatives of our school from leaving home until they return and are thus expected to set themselves a high standard of behaviour both inside and outside the school.
- I. Any misconduct in class with teacher / students/ school staff/ support staff will invite immediate suspension or expulsion in extreme cases.
- II. Habitual late coming/ negligence in assignments, disruptive behaviour inside or outside school campus/ objectionable language/ intentional late reporting for class will invite immediate suspension/ expulsion.
- B. **THE SCHOOL UNIFORM** should be worn tidily and correctly both at school and between home and school. The full school uniform must be worn at all times. Shirts are to be tucked in; socks are to be pulled up; heel straps in place. Where a situation arises concerning a student's uniform, written requests for temporary wearing of non-regulation items must be referred to the / Class Teacher Principal.
- I. Students must report in prescribed and proper uniform. Lab Coats in Chemistry Lab and PT dress with white canvas shoes for sports is mandatory.
- C. **The following are not to be brought on to the school campus:**
- Alcohol or drugs in any form
  - Chemicals
  - Cigarettes or tobacco
  - Knives or other weapons, including BB guns
  - Matches/lighters/explosive or dangerous material
  - Pornographic or any other offensive material
  - Cameras
  - Skateboards or scooters or similar
  - Expensive bicycles or bicycle accessories or other costly equipment
  - Cellular phones/CD players/IPods /MP3 Players



- D. The following are strictly forbidden on school property when students are under school discipline or attending a school function: smoking and the use of alcohol or other drugs, or being in the company of those who are smoking or using alcohol or drugs. distributing of literature or any form of written matter (without the prior permission of the Principal).
- E. Celebration of birthday should be restricted to distribution of toffees only. Only students upto Class VIII are permitted to report in civil dress on birthday. No such relaxation for students of IX to XII. Bringing and cutting of cake, other eatables, collection of money for a party/ celebration/ treat in school campus is strictly prohibited.  
Collection of money/ exchange of gifts / individual celebration on Teachers' day etc. is not permitted.
- F. **BULLYING.** Any form, verbal or physical, or any means of bullying or victimisation is strictly forbidden.
- G. **LITTER.** It is the responsibility of every student in the school to ensure that the school is free from litter. Students are also encouraged to take the responsibility for litter in their immediate vicinity and place any litter in the many bins placed around the school.
- H. Intentional Absenteeism from class: Students are required to attend all classes and remain in the school campus. No student may leave the school grounds during interval or lunch without prior permission. This includes collecting books/any other stuff from two wheelers. Students are not permitted to go and sit/mingle with students of other classes/ streams without taking permission from a subject teacher. When leaving school during the day to attend dental/medical or similar appointments, the boys must sign in and out at the Front Office.
- I. **LEAVE APPLICATIONS.** Parents, please consider carefully the effect on learning and the consequences of asking for leave during school time. The process of applying for leave is for parents/guardians to write to the Principal well in advance, notifying dates and the reason for absence. Each application is considered fully by the student's teachers and Deans, before being granted or otherwise by the Principal.
- II. For Class IX to XII, please read the attached CBSE circular for maintaining exemplary attendance. The school shall not be responsible for students debarred from appearing for final examination for shortage in attendance. It is the responsibility of students and parents to be punctual and regular in school.
- III. **In case of Class IX to XII, all applications, in addition to hard copy, must be emailed on school id boarddata.stanjanis@gmail.com with Subject line mentioning Name Class Section of student and date of absence. If the student fails to secure 75% attendance, as per CBSE rules, he/ she will not be permitted to appear for Final/Board Examination.**



- IV. ABSENCES. If you know your ward is going to be absent for any reason please call the Front Office and leave a message with student's name, class, contact number and reason for the absence. After an absence from school a student must bring, on the day of return, a note signed by his parents/guardian, stating the reason for the absence and take it to the Class Teacher. In the event of the absence exceeding 2 days, the school should be informed whilst the student is absent from school.
- J. All articles of clothing, shoes, books, bags and other personal property should be clearly marked with the owner's name. No responsibility can be accepted for unmarked property. Students losing or finding lost property should in the first instance report to Front Office.
- K. BICYCLES are to be kept locked during the school. Traffic Department road safety rules must be obeyed to and from school. Bicycles may not be ridden in school grounds. It is compulsory for all students riding gearless two wheelers to school to wear helmets.
- L. DAMAGE of any kind must be reported immediately to an In charge/ Principal. In the case of wilful damage or negligence, students will be expected to contribute part or all of the cost of repair/ replacement.
- If any student damages the school property/ Library books/ Labs, he/she will not be permitted to attend classes unless the fine has been paid.
- M. Students suffering from infectious disease will not be allowed to appear for exam/ tests.
- N. Fee dues must be paid on time specified. No defaulters beyond the 30th of the month shall be allowed to attend school. Any delay must be brought to the notice of Principal in writing with reason.
- O. Parents must be punctual in attending PTM. The school sends SMS/ Email for all updates. In case the contact number has been changed, parents must inform the Front Office / Class Teacher. Without their cooperation, the academic performance of a child cannot improve.



# INFRASTRUCTURE

## **BUILDING**

The campus is 100% pollution free with an array of green trees dotting the beautiful landscape with three picturesque gardens. The Fountain of Good Hope near Gate number 2 set amidst a beautiful garden provides an arresting view.

The school has an independent Administrative Block consisting of a Visitor's Lounge, Front Office, Enquiry Office, Principal's Office, Management Office, Director's Office and Fee Executive's Office.

There are seven ACADEMIC BLOCKS with separate classrooms connected by covered corridors to Library, Dining Hall, Science Block Laboratories, Computer Labs, Wash Rooms and a huge covered Concrete Multipurpose Stage.

All classrooms are well ventilated, spacious and airy with good quality furniture. Special attention has been paid in decoration of Nursery Wing and Primary Wing to sustain the interest and comfort of young children. Different themes have been used to give a colorful and vibrant look to the classrooms. An extraordinary Dolls House has been built for students of Nursery to impart education through play way method.


## **PHYSICAL TRAINING**




